## 2. COMPOSITION/INFORMATION ON INGREDIENTS

## 3. HAZARDS IDENTIFICATION

## 11. TOXICOLOGICAL INFORMATION

**Inhalation:** In high concentrations, vapors may irritate throat and respiratory system and cause coughing.  
LCLo (inhalation, rat): 1 gm/m<sup>3</sup> (RTECS) for N-Methyl-2-pyrrolidone.  
LC50 (inhalation, rat): > 590 mg/m<sup>3</sup>/4H (RTECS) for solvent naphtha (petroleum), heavy aromatic.

**Skin contact:** May irritate. Prolonged contact may cause dryness of the skin. Contains organic solvents which may penetrate the skin.

**Eye contact:** Splashes may irritate.

**Ingestion:** Irritating. May be absorbed in the body and cause dizziness, nausea and vomiting.

**Specific effects:** The hydrocarbon: Frequent inhalation of even small concentrations may cause irritability, fatigue and memory failure and eventually permanent damage to the nervous system, including the brain.
